# Strategic Safeguarding Manager Merseyside Fire & Rescue Service

The Strategic Safeguarding Manager (SSM) for Merseyside Fire and Rescue Service sits within the Community Risk Management Team based at Service Headquarters; however has responsibility to inform and advise the Chief Fire Officer (CFO) on all

safeguarding matters and ensure compliance for Merseyside Fire and Rescue Authority with all relevant legislation.

The SSM is a full member of the Merseyside Safeguarding Adults Board (MSAB – Knowsley, Liverpool, Sefton & Wirral), St. Helens Safeguarding Adults Board and all five Safeguarding Children's Partnerships. The SSM is also the Chair of both the MSAB and St Helens Adults Board Communications and Engagement Groups and additionally sits on the MSAB Safeguarding Adults Review Group (SARG).

The SSM alongside other duty officers provides 365 days a year cover in respect of safeguarding matters for Operational Response Crews, Frontline Protection, Prevention and Youth Engagement Staff and all other MFRS personnel.

From a fire sector perspective, the Strategic Safeguarding Manager is the Vice-Chair of the National Fire Chiefs Council (NFCC) Steering Group, which is introducing a consistent national approach to safeguarding across the sector.

# **National Probation Service - Risk and Partnership Lead**

My role is to manage the delivery of risk and partnership work across the Knowsley, St Helens and Wirral NPS Cluster. I am responsible for overseeing effective joint practice between National Probation Service and our various partner agencies, ensuring that risk of serious harm to others is managed effectively through cohesive and mutually beneficial working relationships.

Within my role, I am the designated Cluster Safeguarding Lead and sit on the NPS North West Regional Safeguarding Leads Group, working towards the following objectives:
